#### 1) Description of system of Treatment Process

The Town of Murphy Wastewater Treatment Plant (WWTP) utilizes a 1.4 MGD biological treatment process that includes two 730,000-gallon sequencing batch reactors (SBR), a 175,000-gallon post equalization basin, a chlorine contact basin which uses sodium hypochlorite for disinfection and a dechlorination basin which uses sodium bisulfite for dechlorination. The headworks consist of one mechanical bar screen and one manual bar screen bypass channel used as needed. There are two digestors that are combined 300,000-gallons which feed into a ¾ meter Phoenix belt press for dewatering. There is one Grundfos pump that is used to transfer the sludge to the belt press. The backup power system for the treatment plant is a 300KW Spectrum Detroit Diesel generator with an automatic transfer switch. The influent pumps used to feed the treatment plant are two 100HP submersible pumps with dual high level alarms and SCADA system.
